Thank you again for the work you do to support Mountain Biking and thank you for engaging with the candidates about this!

1. I have family members who are riders and trail builders. I hope to trail run on these trails sometime soon.
2. Yes, I do support mountain biking. Mountain biking already plays a big role in building community and supporting an active and healthy lifestyle, while also supporting local economic development. I hope to see mountain biking continue to grow.
3. The Cumberland Trails provide an invaluable network of outdoor spaces for people to connect with nature, exercise, and have fun in solitude or with friends --> trail networks like these are integral for the health and wellness of locals and visitors alike. The Cumberland trail network has the added benefit of bringing people from all over the world to the Comox Valley to mountain bike - so we also benefit economically, regardless of which municipality or electoral area we live in. From a Community Economic Development perspective, I think there's an opportunity for Comox to draw people to our seaside Town as a place to enjoy and stay while coming to enjoy the trails.
4. I believe that local governments have an important role to play in helping to establish diverse and stable funding streams for non-profit groups who are providing core services for local social and environmental wellness. I hope that the Town of Comox will develop a formal grant in aid program, similar to many other local governments locally and provincially.

1. I do not currently.
2. I think it is prevalent now and many enjoy this amazing recreational sport - all over Vancouver Island and beyond. It has a strong place hold in the future of the Comox Valley.
3. All trails are important in my view and Cumberland Trail Network is no different. It's important that citizens have recreational access - at all levels of ability!
4. I think it's reasonable to allocate maintained funding; an engagement process through your stakeholders would bring valued information as who and how the Trail Network could sustain annual funding. What would a sustainable local government funding model for the Cumberland Trail Network look like to you? The possibility of allocating funding, from all stakeholders including Municipalities, KFN, CVRD, Users and the potential to tap into Provincial and Federal sponsorship seems likely with the growing use and diversity of the Trail Network. A regional approach would benefit the network at the highest level.

Steve Blacklock

1. I am a trail runner and support UROC and the Cumberland Community Forest Society via my annual participation in both the Cumby and Perseverance running events.
2. Mountain biking is a huge and increasingly popular sport / activity for people of all ages in the Comox Valley. I applaud UROC's efforts to manage the increasingly busy trail network.
3. Mountain biking creates both jobs and volunteer opportunities throughout the Comox Valley. The Cumberland Trail Network draws trail users from all over the island and around the world. As an elected

official in Comox, I would continue to promote the “Cumby Trails” to residents and tourists alike.

4. My understanding is that UROC’s annual budget is already funded 20-25% taxpayer dollars via grants. While I realize that grant funding is often thwart with issues and unpredictability, I cannot comment as to whether a better funding model involving the Town of Comox is feasible at this time. In my opinion, future government funding for UROC should most logically come from BC Tourism, VI Tourism, and CV Tourism which in turn funded through taxes.

2. As a family doctor in the Valley, I am passionate about supporting all ways in which we can foster a **Healthy Community, Healthy People, and a Healthy Environment.**

Mountain biking is a great example of a sport that gets people outdoors, participating in a physical activity, while building community.

I am a coach and athlete with the Vancouver Island Biathlon Club. We organize two Mountain Bike Biathlon Races every summer. The participants really have a blast doing a technical course, with shooting bouts in between each lap. There are even penalty loops for each shot that you miss. (See pictures below from the adult and kid races).

Thinking about next summer, it would be great if UROC and the Vancouver Island Biathlon Club could collaborate on putting a race together for your members, to give them the opportunity to try a new sport and put their mountain biking skills to the test on a different set of trails.

3. The Cumberland Trails are an important asset for the entire Comox Valley. I have many patients, friends, and neighbors that also use the Cumberland Trails, many of whom take the short drive from Comox to Cumberland to enjoy the extensive Cumberland Trail network.

In my family practice, I often write prescriptions for exercise and spending time in nature. Mountain biking is

a great activity to promote physical and mental health.

From an economic and tourism perspective, the Cumberland Trails attract visitors to the Comox Valley from across Vancouver Island, the mainland, and the rest of Canada, which supports our local businesses and economy.

4. I recently supported the creation of a Regional Parks Service for the entire Comox Valley Regional District. I recommended we focus on the connectivity of our trails and greenways with our neighboring municipalities, to encourage active transportation and physical activity. A Regional Parks Service could potentially serve as a permanent regional funding stream for UROC, allowing your members the funding and support required to maintain and improve the Cumberland Trails for years to come.
